**New Tuition Policies:**

**Cash Discount:** Pay monthly tuition with cash/check on or before the 1<sup>st</sup> of the month and receive a 5% discount on that month's tuition!

**Pay in Full Discounts:** Pay the entire 9 months on or before first class in September and receive 5% off your yearly tuition! This only applies to September payments.

**Half-year Payments:** Pay the first half of the year on or before the first class in September and receive 2.5% off tuition. (Second payment is due by January 10<sup>th</sup> to receive the 2.5% discount on remaining tuition.)

**Families Registering in October:** Pay full or half year tuition and we will waive the \$2 monthly service fee.

\*All credit card payments will be charged a 4% convenience fee

\*Discounts cannot be combined

\*Tuition is based on total hours per family

***Tuition***

Tuition is prorated and priced for the full 9-month dance season and may be paid for the year, half year, or on a monthly payment plan. Therefore, monthly fees are the same regardless of the number of weeks each month. Tuition is always due the first class of the month and no later than the 10<sup>th</sup> of each month, *even if the 10<sup>th</sup> falls on a holiday or a day we are closed. A late fee of \$10.00 will be assessed to all accounts paid after the 10<sup>th</sup> of the month.* Tuition is due regardless of attendance: The school does not deduct for illness, vacations or absences. We encourage students to make up classes. See our full handbook for complete details.

Tuition may be paid in-studio, mailed, or for your convenience, online via our Customer Portal (you can download the app or access through our website: [www.jamesdancepac.com](http://www.jamesdancepac.com), click "portal," then "account login." This will redirect you to our Customer Portal. Login using the email you provided at registration, create a password, and agree to policies. You will be able to access your dancer's classes, billing history, and studio announcements.

**Costume Fees:** Costumes for the spring performance need to be purchased by each student. *There are no refunds on costume deposits once costumes are ordered.* Ordering begins in December to ensure costume arrival by picture date. **All costume balances and tuition payments must be current before costumes will be distributed.** Costume fees are made in two payments: one in October or November and the second in January or February, with any additional accessory (bows, socks, etc.) or prop fees billed later. The amount of the first deposit is \$75.00 for *each* costume. All costume balances must be paid for in full once ordered. There are no returns or refunds.

**What to Wear:** We are a professional dance training facility, therefore dancers are expected to wear the appropriate dancewear for their specific level. Dancewear will be available for purchase through the studio's Boutique. A complete list of items will be available upon registration.

**Class Change/Drop Fees:** Requests for class changes/withdrawal must be submitted in writing. Requests made after October 31<sup>st</sup> will be charged a \$10 class change/drop fee per class. Forms are available at the front desk.

**ALL CREDIT/DEBIT CARD TRANSACTIONS WILL BE CHARGED A 4% CONVENIENCE FEE.**

**Effective July 23, 2020:**

**All dancers and families, ages 10 and older MUST wear a mask to enter our facility.**

*\*Dancers are not required to wear a mask during class.*

**Student Rules:**

(Dancers and families are expected to follow all rules while using our facility)

1. We shall not chew gum.
2. We shall not bring food or drink into the classroom.
3. We shall wear proper attire in class.
4. We shall not talk while the teacher is talking.
5. We shall not talk while dancing.
6. We shall **not** use our cell phones during class times.
7. We shall not sit down during class unless specifically permitted or instructed to do so.
8. We shall speak respectfully to the teachers and to one another
9. We shall use 100% of our energies while in class.
10. We will not miss class except for valid reasons.
11. We will not run recklessly around the reception area and classrooms.
12. We will wait **inside** the studio for our ride.

\*State Mandates are subject to change with little notice; please follow us on social media and monitor emails to stay informed.

**Lobby Rules:** *These rules follow current mandates in accordance with the Ohio Dept of Health and can change with little or no notice.*

*\*For the safety of everyone, if your child is not feeling well, please stay at home. We will contact the parent of any child with a fever over 100.4 and request they be picked up.\**

**Upon entrance:** All patrons must use hand sanitizer before entering the studio. Also, please follow all social distancing guidelines posted throughout the studio. All patrons must remove street shoes before entering the studios. Dancers are only permitted to bring a dance bag containing shoes for class and a water bottle. Please review the procedural video on Facebook or on the Customer Portal under "Announcements."

**Changing Rooms:** We are currently unable to provide changing facilities for dancers. Students are to come dressed and ready for class.

**Lobby:** *Our lobby is currently closed to all families.* Parents are permitted to walk small children to their classroom door, but we ask that *all* parents wait in their vehicles for their child's class to end. Parents are asked to provide us with a working cell phone number in the event we need to reach you during class (i.e., if your child needs to use the restroom). We will escort dancers out the door after class. Please do not crowd the doorways. Parents are not permitted in the classrooms.

**Restroom:** Please remind your dancer to use the restroom before class. The girl's restroom is designated for student use. Due to social distancing and restrictions, only one person is permitted in the restroom. Because of restrictions, this restroom is also designated as a family restroom. The men's room is for staff-use only.

**Study and Lunchroom:** The study/lunchroom is closed at this time. Students may bring a water bottle to take in the classroom, but no Gatorade, soda, or drinks with straws are permitted in the studio area. **NO food is allowed in any other part of the performing arts center, this includes the classrooms.**

**Lost and Found:** Under the current mandates, *we are not permitted to have a "Lost and Found."* Anything left behind must be discarded, so please make certain your dancer has all their belongings before leaving.

**Teacher Contact:** If you need to speak with your child's teacher, we ask that you make an appointment at the front desk. Due to mandates, teachers are unable to meet between classes, but they will gladly schedule an appointment to go over any questions you may have.
